1. Both Parties agree to undertake joint activities to raise funds for the activities planned. Both Parties will try to use existing financial sources such as bilateral governmental agreements and exchange programs.
2. Both Parties will agree to waive tuition charges for the exchange students they accept under this Agreement on a reciprocal basis.

Article 6

Any changes and amendments in the text of this Agreement shall be introduced only in writing and after the prior mutual consent of both Parties. These changes and amendments shall be treated as integral parts of the Agreement.

Article 7

This Agreement comes into force upon signing and continues in force for a three year period, renewable by explicit agreement. The Agreement can be canceled by either of the Parties with a six-month advance notice or modified at any time by mutual agreement.
